


MASS SHOOTING STATISTICS:

The 2023 is a grim year for the United States, with the country on track to record the highest number of mass killings in recent history, the alarming frequency of such incidents means that the US is now experiencing over two mass killing on average per week. Additionally, as of June 19th, 2023, the Gun Violence Archive has reported over 303 mass shootings in less than 170 days, each involving a minimum of four victims killed or injured by firearms, excluding the shooter. This uptick in violence has sparked concern and a call for immediate action to curb this trend.




Mass Shooting (2021-2023) Mass Shooting (2023)
